




Task Force Structure Changes

Task Force Member Appointment Process

- Conduct broad solicitation of interest to member community
- Candidate resumes reviewed by Task Force Chair, SCOA Liaison, and AASHTO Project Manager
- Interviews conducted by same to find subject matter expertise needed to compliment the current Task Force membership
- Candidate recommendation and all resumes received submitted to SCOA for approval

Members allowed to serve two, three-year terms. Special terms may be extended at the direction of the SCOA


What version of AASHTOWare Bridge Management are you using?




What database software are you using to store your Bridge Management data?




Of the many features available in the AASHTOWare Bridge Management software, please check the features below that are used by your organization. (check all that apply)




Of the available features available in the AASHTOWare Bridge Management software that you are not currently using, please check the features below that your organization plans to use in the future. (check all that apply)




Is cross-asset management optimization of bridge and pavement projects of interest to your agency?




Is your agency interested in optimizing and management features for signs or other ancillary structures?

Do you anticipate that your agency will need support for the transition to SNBI inspection data collection?




